## **STOP #Kids for Cash - #Kidjacking**

**The Big Business of Cruel Child Removals**

There are over 7,400 Oregon children in foster homes across the state. Everyone knows the words "foster homes", "foster kids", "foster parents". All of these words exclude the facts you don't know about and never thought about. That's right, **Parents!** Where are the parents?

All assume that the parents are bad and so the kids were taken. Sometimes kids do need to go somewhere else to live, but studies show that even in bad homes children turn out better than in foster care. DHS has made the parents invisible. There is no word for them. The parents go unrecognized by society and are assumed to not count.

The real story is much different. When each child is removed from a family a huge cash machine of taxpayer money begins to spew out cash to a score of workers and services far and above what any parent could imagine. While a low income family with 5 children might be getting as much as \$1,000 a month in food stamps each one of those very same children taken into the clutches of the state becomes a cash cow generating thousands of dollars per month for foster families, lawyers, counselors, case workers, transport workers and CASA workers. All supposedly in the name of protecting children, but really in the name of cash. Mountains of it. The average child in state care in Oregon costs taxpayers a whopping \$\_\_\_\_\_ per year. (Ask your legislator) (\$100,000 est)

## Purpose of this Book

This book is an introduction to the destructive tactics DHS/CPS and the secret courts use to take your children away from you without evidence and without due process. For a speeding ticket you have the right to a trial by jury. DHS/CPS can take your children without a jury and no due process in their jurisdictional trials in secret courts where DHS/CPS actions, judges' actions and court appointed lawyers are all protected by "gag orders" that supposedly prevent you from talking about what they are doing to you and your children.

Information given here should keep you from being **surprised** by the cruel trauma that DHS/CPS will place on you and your family. This will be the fight of your life.

Hopefully you will be able to defend yourself from the **evil brutality** DHS/CPS will undoubtedly bring to your life. Here are some of the events that people have faced so that you will at least have time to plan and prepare yourself to face these evil deeds by DHS/CPS workers and judges. The rule of law is over. The courts are corrupt, a scam in a rigged system. The fix is in. Cozy court appointed lawyers will allow injustice to prevail.

DHS/CPS case workers lie in court, allow false testimony, hide discovery that will clear your name, suppress evidence and stack the case against parents all for millions in cash.

DHS/CPS Oregon gets Federal Title IVE funds **ONLY** if they remove your children. The trauma they inflict on your children in so many obvious and subtle ways is without excuse. Their arrogance knows no bounds. They live in valuable homes with secure well paid incomes and promises of advancement to higher pay grades. Refusing instruction, DHS/CPS workers make their choice salaries off your children who are the cogs in their money making machine. Your case worker is making \$45,000 and up per year. Her area manager is making \$100,000 and up per year. Yes, you read that right, taking your children.

With Oregon claiming to care so much about women's rights the devastation DHS/CPS inflicts on mothers is unforgiveable. Federal Title IVE funds for destruction.

Maybe you have an exemption for vaccines? Maybe you home school your children? Maybe you are in a bi-racial or minority marriage? Maybe you are from a low income family? Well DHS/CPS has a plan for your children and it doesn't include YOU beyond the heartache they will cause you, the sorrow that you can not now imagine.

In the end DHS/CPS can not take your hope, your faith, your peace or the Love that God has for you. We have an obligation to help others survive this great evil and demand that there be an accounting for what is being done in these secret courts by people paid to traffic our kids. How to protect your family from DHS/CPS, corrupt law enforcement, state terror, medical kidnapping and child removals. The family guide for fighting back.

## DHS/CPS Will Destroy You

DHS/CPS will destroy you before you figure out what is happening and get up to speed. The “court appointed lawyers” will completely fail you and sell you down the river. It is planned this way. This booklet is to help you come up to speed and **shock** you into realizing how serious and deadly their agenda is. You need every chance to protect your children, your marriage and yourself.

First understand that their actions are highly organized, well financed for the removal of your children and the destruction of your family for massive financial profit for agencies and social workers. (Yes, that is right, all those “nicely dressed” people) Your children are **cash slaves** and **child sacrifices** on their evil altar of greed and injustice.

What DHS/CPS will do to you and your children which you will watch in slow motion is like having your children killed in front of you. Something dies. Your heart will break. Your soul will be crushed. DHS/CPS case workers are ruthless. They are the children of Satan. They are not human. You are not dealing with people who have consciences or normal human responses or compassion. They will take the most common things and turn them into something evil. They will go in and out of DHS/CPS buildings in all their finery. They may even belong to your church. Of course they all know they are not being paid nearly enough. You will never deal with people more evil than DHS/CPS.

## How to cope and protect yourself

1. Immediately note when DHS/CPS workers first target you and where it is coming from.
2. Do NOT allow DHS onto your property or into your home even if they bring the cops.
3. Understand DHS/CPS destroys families and causes enormous financial hardship.
4. Increase your security, lock your gate! Install video on the approaches to your home.
5. Do not talk to the police. Do not give information to DHS. They are not here to help you. **Anything** you or your spouse say **WILL** be used against you. Count on it.
6. **Never** make any “admission” to DHS or the Police no matter who suggests you do so. DHS will **LIE** to you and make promises they **NEVER** intend to fulfill.
7. Circle your friends and discover your resources: Family, Friends, Financial..
8. Think about what you can sell or may be forced to sell.
9. Tighten your belt. Halt unnecessary expenses.
10. You will need to survive financial destruction in the worst event of your life.
11. Conserve energy, simplify other parts of your life. Take care of yourself.
12. Protect your \$'s by finding a good lawyer first. Not easy to find. Bad lawyers are no bargain no matter how much they charge.

13. Learn what a good lawyer can and can't do (or won't do) for you.
14. Know what you have to do on your own.
15. Contact your Legislator and Senator both State and Federal. Be at Town Hall's.
16. Get involved, educate yourself. Don't spend all your time blaming yourself.
17. Get on line to join related forums. Build a support network.
18. Help and encourage other abandoned families.
19. Realize there are no advocates for parents. Join or start a support group.
20. Don't waste time talking to people who don't care, expect that friends will walk away.
21. Keep a journal. Take notes. Write down what people said or did, time, location, date.
22. Know that court and visitation days can be devastating.
23. Don't expect other people to understand what is happening to you, most won't.
24. Will your church stand up to DHS/CPS ?
25. Educate people in your church.
26. Identify DHS/CPS case workers in your church and people working for DHS as support agencies or "contractors" who are profiting off this incredible evil brutality. Observe and avoid. Your children are a financial cash feeding frenzy for these people.
27. Renew your faith in God and prayer.
28. Preserve and strengthen your relationships.
29. Take care of your health at this time of extreme stress, loss of appetite and insomnia.
30. May God bless you and keep you, your spouse and your children safe.

### **Government Accountability - Elected Officials**

Contacting government officials or elected officials can rapidly feel like an exercise in futility. Unresponsiveness or ineptitude is what you may encounter. Make appointments and ask questions. In doing so you burn the bandwidth of otherwise unresponsive government officials. If hundreds of parents do this, they will have to reconsider their ways. It is about holding them accountable. Government officials easily push you to the side because they are incompetent to do their job, lazy or lacking in concern. They are out of touch with the reality of the lives so affected by the government they are appointed to oversee. Seldom will you feel they understand your concerns to the point they are going to take it upon themselves to investigate beyond being brushed off by DHS/CPS. "Oh, DHS told us....." and they move on.

### **Some things to brace for:**

Your friends and family may turn against you. Churches look the other way. (They cooperate with government agenda to keep their 501-c) You may lose your job. You may get evicted. You and your spouse may get separated by the judge, divide and conquer. These people are cruel.

This will be the most difficult time of your life. It will test you to see what you are made of. You must hold all the complexities of your life together and somehow make it through.

## About DHS

DO NOT believe for a minute that they are here to help you.

DHS/CPS do not believe that the state Constitution or US Constitution apply to them. They have no problem violating your rights and assume you will not be up to speed as to what those rights are and how to defend them.

There is no punishment for DHS workers lying, making false or misleading statements in court. Their agenda is to destroy you and keep your children as long as possible for cash.

DHS will find, coach and bring every person they can to testify against you and will have experience with YOUR judge. They will know pretty well what YOUR judge requires from them to decide to put your children in state jurisdiction and hand them over to DHS. You might think it just happened to you for the first time and not understand how the game was rigged before you got there. They are good at taking children. They do it all the time. They have a plan. A child eating machine that **NEEDS YOUR KIDS FOR QUOTA**.

DHS and other social agencies like CASA will not make any positive comments about you in their notes while you have visitation with your kids despite the fact of how traumatic it is for you. Everything they write will be derogatory. You will not believe what they will say against you in secret court. They will make every attempt to turn your children against you.

The Governor's Advocacy office works for DHS. They are there just to make you think you are working with a just government. You are not. They are **TOTALLY CORRUPT**. The Citizen's Review Board is in the DHS pocket and is part of DHS. For all practical purposes the judge does not work in a court of law but works with DHS against you. One big happy family at your tragic cost. You will find out that the American "justice system" is a lie.

DHS can best be compared to the American version of the Gestapo. Each well paid person talks about how over worked they are while violating your rights at every turn. The Governor and Legislature will talk about how much more money they need to throw at DHS for new case workers and new viewing rooms in the child trafficking empire. State confiscation of children is a form of genocide against lower income families, families least likely to have the resources to fight back against so many people. Children in foster care seldom fair better than they would if left in their families.

DHS allows and promotes anonymous reporting, a violation of your constitutional rights to face your accuser. Hot line reporting can be absolutely false by a disgruntled family member, neighbors or medical personnel but DHS will act against you. They pretend it is out of the need for utmost caution but it is really about growing their child trafficking empire. **DHS primary goal:** Single parent dependent families. Removing children for #cash. Criminalizing husbands and boyfriends.

## **#Kids for Cash - The DHS Child Trafficking Mafia**

DHS is a well funded agency that makes enormous salaries by taking your children. The definition of child trafficking is the movement of children for the purpose of financial exploitation by means of deception. By taking your children they make profit for scores of people in the “helping business”. Protecting your family is not profitable.

### **DHS vs. CPS**

Child Protective Services conducts the raid with police to take the children. This is the ultimate evil. Once the children have been taken DHS takes over.

### **DHS/CPS - How it works: They receive Federal Funds for every child TAKEN!!!**

While you will be new to this, DHS already has a plan and a system for how they take children. They are way ahead of you. They will have a highly organized, well paid system set up to take your kids and keep them away from you for as long as possible while forcing you to jump through their hoops in the hope that you will get them back if you do everything they say. Sometimes that works, mostly not. They like subservient parents who bow to their demands.

### **People they use against you: (More about this later)**

1. Accusers will be schools, doctors, extended family, ex spouses, your own children, step kids, neighbors, police and a multitude of anonymous accusers.
2. Supporting agencies - CASA, Cares NW, Liberty House and many others.
3. The Police, Judges, District Attorneys, court appointed lawyers.
5. Case workers, supervisors, managers.
6. Counselors, therapists
7. Foster families, observers, transport personnel.

### **Lies and Deceptions:**

1. Realize that case workers and police will lie or sensationalize a case against you with the willing and knowing assistance of the local press. A famous quote says that the government is a whore house and the media is their piano man.
2. DHS/CPS and police hide exculpatory evidence.
3. The media will destroy you. Even if it turns out your case is dismissed the damage can not be undone and that is the plan. It seems to justify DHS/CPS having taken your kids. The media goal is to help turn the public against you with highly sensational accusations in order to help the establishment destroy your family. It is shameful what America has become. It is foolish to think we have an honest justice system or honest media. They want fast selling sound bites and to build their careers. Strong libel laws would put the media whores out of business.
4. There is no penalty for police, DHS/CPS workers or accusers who lie or rig your case against you.



## **When DHS Comes Knocking:**

### **What you will face**

No Warrant, No Court order? Then don't let them on your property or into your home. Just because they brought a cop with them doesn't mean they have authority to do jack. First of all, if you have any possibility at all, just get out of the state. You will think that what you are experiencing is unique, even if it is very troubling. But why should you be surprised with what DHS does to you and your family? If you read what we will describe below you will realize that they are doing this very evil deed to many, many families with extreme trauma to parents and children over and over and over again.

### **DHS will OWN your family.**

There are many ways you can enter the DHS system. Just think of the many times police pull people over for supposedly that missing tail light as a means to justify the stop. Some outright event or even superficial event may trigger DHS to spring into action and take your children. They will say they are taking your children because of "risk" or "in the best interest of the child".

### **Examples:**

A domestic dispute

An emergency room visit where staff are trained to try and impose "abuse" definitions on what they discover. Remember, there is a LOT of money to be made by taking your kids and DHS has many enablers fishing around for opportunities to feed this evil machine.

An anonymous report

An angry neighbor, busybody

A teacher. Someone at church

Other "mandatory reporters"

A mishap on a family outing

Poverty

Being a bi-racial family

Being a minority family

Being a handicapped family

A missing baby seat or seat belt

An ex spouse

Child custody dispute

In laws, grand parents or other family

Your friends and family will say stupid things that DHS twists to use against you.

Bottom line is you may not have noticed anything out of the ordinary. Your kids are playing on the front lawn. You run in to use the bathroom and the neighbor calls the hotline for "neglect". That is all DHS needs to trigger their child kidnapping.

## **Coping With Devastating Panic DHS/CPS Just Took Your Child!**

Your heart will be filled with terror as you see your babies taken away crying by the CPS/DHS case workers and the police. These are the most evil people you will meet. Maybe you were married one time and you think your spouse was a really bad person. They have no comparison to what these people will do. CPS/DHS will cut into your heart pains that you could never fathom. Like an ongoing death every day. A mortal wound to your soul.

I won't tell you to call your legislators because I think they will care about your case. But you can and should. Over and over. Let's hope they become weary. Let's hope it takes up more of their time than any other single issue they deal with till it becomes important to THEM. I won't tell you to sign a petition on line or open a go fund me account. I will tell you to hold on. Do not completely despair although you are up to your neck in it. Short term, grab as many people who can help you hold on. Longer term look at how you can find ways to bring wrath on DHS/CPS. It takes a solution. They have become too powerful. They are not afraid of the people. They expect the people to be afraid of them.

There are no good fast solutions right now because DHS/CPS is an out of control cash cow that greedy, selfish, feckless legislators have allowed to happen because for the most part it is not happening to them. We think we live in a democracy but we don't. Our government is so evil and getting worse. Sometimes you have to be the one to lead, organize, become available to others and pull together a resistance. A good lawyer is a partial solution but the money you spend, over \$50,000, won't fix the anger that you will experience as to how this has all been set up. Dig deep in your heart, draw near to God and friends. Take care of your spouse and children best you can in these circumstances. Turning on each other now will not help you. Blaming each other will not help you.

Have people you can call at any time when the stress of the situation crushes your soul just one more time. That is what it is like. Desperate aloneness. Look around, do you see DHS/CPS getting shut down or getting the pain they so gladly inflict on others? Everywhere you look DHS has bigger offices, new buildings, and there are CASA signs everywhere. This is the big big business of child removals. Few people know the terror families experience. Until it happens to them, they think it is all justified. Parents are to blame, because DHS said so. You will not believe the number of people who have sold out to the government corruption because they or someone in their family has a government job and is getting a nice, fat paycheck and PERS retirement.

Be one of those who do something in your time of greatest need because now you have the power to become a force. Organize, communicate. Help get literature out there. Bumper stickers. T shirts. Go to ground and fight back. If our legislators wanted to do something they could halt the budget. They could fix the disaster. But they choose to be impotent.

## **DHS Trials in Secret Court: How DHS Takes Jurisdiction of Your Children**

**Traffic Tickets allow you to ask for a JURY TRIAL but you will not be allowed one when DHS takes your KIDS!!!**

Think about that!

Your Constitutional right to a jury trial, to face your accuser.

Judges will ignore the law. DHS will ORGANIZE false witnesses against you.

DHS will take complete control of your children when the judge assigns them jurisdiction and will spin all events against you from the smallest of details, all **without evidence**. In all your life you will not find anyone as evil as the DHS/CPS Family Court System. If they all wore arm bands maybe they would be recognized for what they are.

### **Court appointed lawyers:**

You will be assigned a useless or less than useless court appointed lawyer that kisses up to the court.

Court appointed lawyers for the children will agree with the mood of the judge and side with the judge against the family. They will not fight for or protect the rights of the children. They will not fight for the constitutional rights of the children to their family. They do not answer the children's phone calls. They fail to take prompt action on behalf of the children but still get paid. They will allow the court to abuse the rights of the child and say nothing.

### **What You Will Face in Court: Its rigged folks, the "fix" is in.**

You will face seasoned DHS case workers, who are masters of guile, deception and betrayal.

You will not be prepared for the sinister, cynical approach and actions or statements that DHS and their horde will make against you.

The DHS actions will be in a secret court. No Jury. DHS's goal is to work with the judge against you. You will be facing a seasoned DOJ attorney working for the state and DHS as one of the state agencies. They will be experienced at twisting the law and doing the most damage to you as possible. They are there for one reason, to win and to savage you in the process. There will be at least ten if not more people in the courtroom who are there to go against you on DHS's behalf. All dressed nicely, like for a public hanging. Except this will be in secret. If it were conducted in a basement with a single bulb hanging from the ceiling it would fit the situation more accurately. The smell of death is in the room. The death of your family. The death of everything you love. The DOJ attorney and all the others will do their best to make you look like an unfit parent.

DHS gets Federal Title IVe funding if they remove your kids. They don't get that money into the state if they just work with your family to make life better.

DHS has been corrupt for years but legislators have failed to protect you and other families by failing to holding DHS accountable. Legislators talk about their struggle to hold DHS accountable sans enforcement legislation. They have failed because they fail to ACT.

Your children have become “foster children”. The state continues to fail foster children who are abused and die in foster care. Your children are best in your home with FEW exceptions but foster children provide enormous “employment” for a host of parasites lined up to take the cash, and thus we call it “#Kids For Cash.”

In your dealings with DHS about your children DHS will figure out what you want and don't want and they will do what they find to be the opposite and most painful for you.

**You will have no idea of how the court is going to be used against you.**

The DOJ lawyer will do their best to intimidate and threaten you with **Termination of Parental Rights (TPR)**. Evil Theatrics. You will think, “This can't possibly be happening!”

If you hire your own attorney (recommended) you will first be faced with finding one who has experience and passion for fighting the injustices of DHS. More than likely hire from out of county so that they haven't had a lot of experience sleeping with your particular judge. You will need to meet with several and see what their connection is to the court you are in. Do your own background check. Have a conversation with them. What cases have they fought against DHS? Pay close attention to what they say about things like plea deals. If something makes you nervous about what they say, pay attention to it! Don't plea. Lawyers are often supportive of the erroneous legal system that employs them.

Plan on spending at least \$50,000. Your attorney will hire a private investigator. That will be in addition to his first retainer of say \$10,000 to \$20,000. Expect \$20,000 and an additional first retainer of \$5,000 for a private investigator. More if he has someone like a valuable forensic nurse on his list. There are no shortcuts. You will exhaust all your money, all your assets and your family and friends money if you have any at this point. Remember you opposition will be well paid to show up and testify against you - they want your kids!

DHS/CPS will do all in its power to take and keep your kids as long as possible and look at adopting them out.

In court you will see a host of well dressed well paid people working to take your kids. They are NOT there to help your family. They will have unlimited funds to take your kids, far in excess of anything you had to raise your children with and pay your bills. YOU are their paycheck and they will cash you in time after time after time.

Ask your friends to show up at your major court dates. Even though the system is corrupt it is important that you have friends there to witness what they are doing to you and your family as most people will not believe it. You will even doubt what you just saw happening. Supportive friends are the most important thing you have in your life at this time. Every time you talk to your lawyer your bill will go up.

## **More DHS Tactics: How DHS Works Against You**

### **What DHS will do to you and those you love:**

DHS's number one goal is to take your children and destroy your family to promote their ever increasing budget.

DHS will cause trauma to your children. This trauma may be far in excess of any evidence they have of "abuse". They consider this acceptable "collateral damage". In other words abuse of children is OK if DHS does it. This includes emotional trauma, physical injury, physical abuse, sexual abuse, forced vaccination against parent's wishes and exemptions, multiple foster homes, separation of siblings and ultimately death in the foster home. The next time parents will see their baby that DHS kept so "safe" it may be in a coffin.

DHS is controlled by no one. They are a state within a state. They are like communists. They are like Nazis. What is the difference? Both groups have ultimate power to abuse and did. Ultimate power. Ultimate evil. The abuse of the people by the state.

DHS will send the police to your home on any pretext to begin their investigation.

DHS will try to force their way into your home. They will violate your rights if you are not informed.

DO NOT allow the police or DHS onto your property or into your home.

DHS will attempt to get the mother to testify against her husband or boyfriend with promises it will help her get her children back. The man will at least be one of their trophies when he is in prison.

DHS will try to get the mother to site domestic violence.

DHS will encourage a restraining order.

DHS will collude with the judge to get a no contact order between the mother and man, forcing the man to move out and away, breaking up the family and straining the survival relationship they have, making the mother more dependent on the state and susceptible to their pressure. This can destroy the relationship and cause enormous financial and personal hardship.

DHS will promise money and housing to try and lure the mother to testify against her man in order to find means to charge and prosecute him and take him out of the picture. This is especially important in states with corporate run prisons.

DHS will use in-laws, ex-spouses and extended family against you.

DHS will find any means to use older children's wishes against you even when the older children may not know how they are being manipulated.

DHS will demonstrate to your kids that they have more power than their parents. (Matthew 10:21 And the brother shall deliver up the brother to death, and the father the child: and the child shall rise up against their parents, and cause them to be put to death.)

## **DHS/CPS Tactics Cont'**

DHS will fail to provide timely discovery as required by law. The judge will ignore that.

DHS will conceal discovery that will clear your name and show that someone lied.

DHS will get away with any illegality they can. They are willing to act illegally.

DHS will mislead the court.

DHS will deny you your rights during visitation.

DHS will tell you that you can not take photos or videos of your children.

DHS will get the foster family to work against you.

DHS will NOT follow recommended frequent visits required for infant children.

DHS will tell you nothing about their actions or the legality of their actions.

DHS will work by bluff or with impunity knowing that the inexperienced family will have no way of knowing their actions are illegal or how to stop them. A vigilant lawyer \$\$\$ will be constantly fighting their attempts to thwart the law.

Emergency room staff are trained and consulted by DHS to portray injuries as abuse.

DHS will demand you take classes that are extensive as conditions to get your children back. They won't tell you before you agree that you won't be able to get your kids back till you have taken at least 12 weeks of classes. Always a hitch. Time delaying tactics because lots of people are making money off each one of your kids each day. This intensifies the alienation of your children.

DHS will attempt to force the immunization of your children.

DHS will know nothing and admit nothing about all the good healthy aspects of your family and will use every language and opportunity to attempt to capitalize on the negative.

DHS will have foster parents believe parents are bad people. Parents are discredited.

DHS does NOT have a procedure for vetting false accusations so they do not vet for false statements by accusers. False accusers are **NOT** prosecuted.

DHS supervisors have no comment when it is pointed out that there is no accountability for violations of DHS workers, no discipline, no one being fired or written a citation.

**In society “foster parents” and “foster mom” are positive image propaganda. Real parents are completely invisible.  
Our goal is to make parents HIGHLY visible.**

**You have a constitutional right to your children and your religion. You have a constitutional right to NOT vaccinate your children.  
The State of Oregon IGNORES these rights.**

### **DHS/CPS Tactics cont’:**

DHS will NOT report or document abuse committed by an accuser. They ignore mandatory reporting in these cases. They will NOT document anything that contradicts their agenda.

DHS is NOT pro family but pro state control of families.

DHS is pro single parent families.

### **Divide, Conquer, Make Dependent**

Alienate husband and wife

Make false statements

Conceal evidence or documents

Delay delivering documents/discovery

No due process, no 12 person jury

Violation of constitutional rights

Secret court

Take children with no **evidence** of abuse

Talk about the “risk of abuse”

Make negative comments in their reports, not objective reporting

Make one parent move out

Fail to notify extended family

Delay Delay Delay

Mention a report that is negative then deny it exists when you ask for it

Twist the comments the foster parents make in passing without foster parents knowing their simple comments got changed and used against family in the DHS reports

DHS stands by while police prosecute and jail innocent parents

Court appointed lawyers tell parents to make admissions even if they are not true

Courts allow DHS abuse of power

DHS will threaten a parent that they will take a child if they don’t testify against the other parent.

Stop face to face visitation

Cancel a visitation and fail to make it up to the parents

Convince parents to plead guilty in criminal court

Make outrageous demands on a family, like that they move to get their kids back.

Disregard expert witnesses.

### **What happens in court will be far different than you expected.**

You will not be able to stop the train. You will only be a witness to the cruel execution of your family and the lives of your children. You will see how many people are in court on the side of DHS to testify against you or recommend all the things which must be done to you and your kids. You will be stripped of all your rights as a parent.

## **DHS/CPS Tactics cont'**

Fast track termination of parental rights and adoption

Try to destroy families instead of reunite

Traumatize children and especially infants

Get a court order on false allegations

Invite disgruntled ex-wives or ex-husbands in order to sway the court

Target bi-racial or minority families

Target low income families

Target handicapped families

Target families with health issues

DHS disqualifies a relative for a foster parent while putting a child in a much worse situation.

DHS takes action they know to be unsettling to the parents

Paperwork will list "Adoption" as concurrent plan. This is how they intend to terrorize you the entire time.

As a carefully orchestrated mafia, DHS uses agency (paid contractors) statements with no regard for the truth, as justifications for their rulings. Whores of the Court.

DHS will bring witnesses to court to make false statements against you with NO evidence and the judge will gladly use this to justify taking jurisdiction over your children and making them wards of the court. It will not matter that you know this is not true. You will have no recourse.

Lawyers can show that something is true but the court can easily choose to ignore it. Did you get that? Take your children with no evidence, no forensic evidence, No jury, then prevent you from discussing the case that just happened to you and your children in the court.

DHS will press the judge for certain actions like forced vaccinations even if you have exemptions. Then when they are asked they will slyly say they were just following a "court order".

How much is being spent on your children? On each child?

There is no criminal liability for DHS workers destroying lives with deception. They are never called on the carpet to answer to YOUR accusations against THEM.

**Talking to politicians such as county commissioners or legislators is important if only because it burns their bandwidth and DHS bandwidth. However I am sincerely skeptical as to how useful it is apart from that.**

### **List of Tactics Corrupt Judges Use to Wrongfully Take Children from Protective Parents:**

Perversion of justice: No Accountability, No Transparency.

Corrupt judges: They will lie about what was just said in the court.

Secret courts

Wrongful jurisdiction

Wards of the State

- Judges often meet in Chambers with all Attorney's, and support agencies to make deals without client present and no audio video proof of what is being said "off the record".
- Judges ignore testimony, facts and witnesses
- They will intentionally confuse issues in a case and attempt to confuse witnesses who are on the stand
- They will use Courthouse Security Guards to intimidate people, by interrogation or by following you
- They will collude with court appointed lawyers and make decisions without logic or proof
- They will deny you due process
- Frequently ignore the law and your Constitutional rights
- They will make biased judgements against you while the other party will break court orders with full judicial immunity
- Threaten you to sign paperwork under duress without discovery
- Allow certain parties to commit fraud upon the court (perjury) while the other party is threatened into silence
- Judge will institute court orders which they will break, or allow one party to break, while other parties cannot
- They will never admit wrong doing, even after proven that they erred.
- Judge will ignore witnesses or evidence that does not fit the desired narrative
- Judge will continuously side against one party
- Ignore crimes from certain parties
- Rubber stamping everything one side does
- Sealing documents so crimes are hidden
- Placing no contact orders on husband and wives, forcing one to move out and damaging the family
- Placing gag orders

**Place video cameras in all family court courtrooms.**

- Changing or removing the court recorder's record
- Failure to consider evidence or hear petitions - Take kids without physical evidence.
- Denying constitutional or civil rights - US Constitution: Article 14 "due process" rights

### **Deceptive Law Enforcement Tactics**

Law enforcement officers are trained to lie, make false statements, mislead, try to entrap, hide facts, twist facts and timelines, emphasize one fact while completely concealing or downplaying another fact that gives context. They will conspire at the station how they are going to set someone up with the appearance that there is "evidence". Law enforcement will write up one set of statements while totally ignoring or downplaying another set of statements or testimony that contradicts their desired outcome for an arrest. Matter of fact, the contradictory information and statements may not appear anywhere, as if they never happened. That is why in the US today there is a very low level of respect for law enforcement. Law enforcement will use accusations with NO evidence to persuade a grand jury.

### **Deceptive Tactics of Supporting Agencies**

Have you ever read in the paper that such and such happened according to an "informed source who is not at liberty to speak to the press" and that is why their name is not published? Well in fact, the publication is using a very sleazy standard of journalism because they are basically quoting a nobody as if they were a reliable source for the article. And then someone else will quote that publication and before you know it you will think it is so true that you can even look up the original person and ask them yourself. Well, of course you can't and that is exactly the problem.

So when you and DHS are in court, DHS will roll in all their "supporting specialists", "supporting agencies" and use them to prop up their case against you as if their being there suddenly makes it all legitimate. But it makes the sham court look good while they destroy your family right in front of you. And if they are all proven wrong? Do you think they will back up and correct the problem? Of course not.

### **The People Marshalled Against You Endless Money and Power**

Nurses

Hospital staff

Teachers

Activist judges

You will not find one friend. If you are facing criminal charges also then you will not testify on your own behalf. What you say WILL be used against you in both cases.

The press won't believe you. They will publish the sensational.

Lawyers won't take your case or they will take your money and may do very little.

Many if not most people will figure you are guilty of something so they do not care, won't ever happen to them.

All kinds of supporting non profits and service agencies are used to “extend services” to DHS “families”. Keep in mind that these supporting agencies are private contractors and they are paid royalty for what they do. In other words your kids are BIG BUSINESS.

Gold Diggers and Foster Farmers.

### **What This Will Cost You:**

Plan on easily spending \$50,000 to \$100,000 dollars. A good lawyer is hard to find. A bad lawyer, of which there are many, will cost you more money than a good lawyer. If you don't have time and money to do it right when will you get the chance to do it over?

### **How Long Will This Take?**

Your case may take from months or until the rest of your life.

The Concurrent plan for adoption: DHS/CPS has a concurrent plan for adoption. They use this as leverage from the very start. This is a way to terrorize parents. The DOJ lawyer will push for Termination of Parental Rights. They refer to this as “TPR”.

After DHS takes your children, your children will be living the life of the damned. This is especially true for the trauma your babies will experience. Hours stretch into days, days into weeks, weeks into months and months go on past a year. Your life has stopped. All that was dear to you and “important” and joyful has faded into the past. You have to find it in yourself to be able to weather this storm that is thrown against you.

All in a day's work for the Devil's own at DHS.

## **Your Advocate?**

There is no one fighting for the parents.

Parents have no advocate.

Think about that. DHS and the courts have all their people assembled against you at taxpayer's expense, and there are no advocates for you?

Whatever the parent's situation nothing justifies DHS and Judge's abuse of power. And that is what it is. No oversight, no transparency, secret courts.

There is no advocate for you to make sure the court appointed lawyer pulls their head out of their ass and quits kissing the judge's back side while you are destroyed.

People will give you all kinds of advise: Do this, do that, go see so and so. Have you contacted your legislator? Hopefully they will be there for you in court and gain a realistic idea of how brutal the system is going to be to you.

## **Surviving Visitation:**

Not one complimentary statement by DHS case workers or CASA workers in their reports from visitation times. This is emotionally exhausting. Room observers can be a little bit better about this.

### **Visitation:**

1. Can be very stressful (and that night and next day)
2. Plan stress relief before and after visitation. De-escalate.
3. Don't feel guilty if you do a time out or something fun to cope. You are saving and mustering emotional energy for the long fight for your children.
4. Set up a series of moments and activities you do to honor your children in this terror.
5. Have something special for your kids each visit however small.
6. Read in the Book of Psalms every day.
7. Never accept that it is OK that they stole your kids.
8. Realize that they may adopt them out.
9. People say "be cooperative". What? With Satan?

## **Misconceptions:**

1. Only bad parents lose their children - Wrong!
2. Bad parents have no rights so it doesn't matter what lies DHS makes up - Wrong!
3. Your children can't be taken based on false reporting - Wrong! You have a constitutional right to face your accuser. Anonymous reporting violates this right.
4. Police don't lie - Wrong! Police are taught to lie in order to incriminate and entrap.
5. Only OTHER people lose their children - Wrong!
6. Courts are fair. No. They are manipulated for a pre-determined outcome.
7. Police don't knowingly put false statements from accusers in police reports and prob-

able cause statements. Wrong! Police will stack the case against you so that the press will pick up the story and print it, prejudicing the public against you. When it turns out there are no facts to back up the accusations will the press or the media retract their story? No. Absolutely not. Even though they have destroyed your reputation.

8. DHS workers don't lie. Of course they do.

9. DHS/CPS will say they are "here to help your family". What a lie. The record shows they are here to destroy your family.

### **Do's and Don'ts**

Do NOT involve in drugs or have any drug user on your property or visit their residence. Do NOT engage in anything that can become domestic violence. When you have your children taken from you for whatever reason emotions run crazy high. Partners can fight as a result. Take a time out. Always remember to leave if there is a confrontation and **Take that time out!**

Do NOT use alcohol during difficult times like on days of visitation or court.

Do NOT let law enforcement or DHS/CPS on your property without a warrant or court order.

Know where your kids are and what they are doing and who they are with and when they will be home.

Wear a body cam whenever possible if you have a DHS/CPS case.

Keep a journal. Take notes every day. Names, names, names.

Do make DHS put everything in writing.

Don't trust DHS claims that they are trying to get your kids back to you.

Do build a close circle of friends to support you in what is going to be a very very rough ride.

Do seek God's help and guidance. Pray without ceasing.

Do contact your legislator because you will burn their bandwidth and add negative connotations to the DHS name. Remember the squeaky wheel gets the grease. The legislature and Congress have failed to reform the laws that encourages DHS to take kids. There is massive money in the child removals. It IS child trafficking. Constantly follow up. Go to their office. They like you to make an appointment. Sometimes just popping in is of more value. Pressure legislators that it is their job to fix the problem. Assure them that their performance will be a campaign issue.

Do realize that DHS will exploit any flaw, discrepancy or difficulty in your family: financial, emotional, racial or even a handicap.

**When you lose your children you will wonder how you could have been so misinformed.**

Do NOT admit to anything. Never sign an admission. DHS and deadbeat court appointed lawyers will try and trick you and sell you down the river. They will even try to make you make a false confession with promises it will help you get your kids back. They will use this against you, it will not help you get your kids back.

Be strong, Be relentless, Be aggressive.

You are welcome to your emotions. Manage them well.

Never make threats or insinuate threats

DO try to make your relationship better. Do not believe DHS when they tell you that if you testify against your spouse you will get your kids back.

### **The Citizen's Review Board**

Citizen Review Boards CRB is NOT for you but is there to rubber stamp DHS actions. They invite you to speak in the announcement letter but they don't intend to leave you time to do so or they will not want you to talk freely. They will do their best to sideline you and keep parents from speaking. They will not document your statements citing illegal or coercive DHS actions. This is their means of claiming they have oversight. They will say they will make "recommendations". Then they will say that they cannot force DHS to follow them. So what is the point? To make you feel there is hope when there is little?

### **Finding a Good Lawyer**

Court appointed lawyers will make deals in judges chambers.

Court appointed lawyers will dismiss or ignore or downplay important and shocking evidence that will clear your name. They dismiss valuable witnesses without your consent.

Court appointed lawyers will ignore events which are the immediate basis for a mistrial.

Court appointed lawyers will not return phone calls or emails.

Court appointed lawyers will down play how dangerous and treacherous DHS trials are to you and your children.

The pool of court appointed lawyers working in close proximity to the same judge every day reeks of failure.

A court appointed lawyer will fail to oppose the judge. A lawyer will fail to stand up and ask for a mistrial when the judge harasses the witness. When DHS withholds discovery, the lawyer will not contest it, jeopardizing the family's defense.

**Foster homes for children are often the result of DHS abuses. We often hear that there are not enough foster parents for the *growing* DHS #kidsforcash child trafficking business.**

The lawyer will say, “The DHS trial is not important, the criminal one is.” Bull. They are BOTH important. The lives of your children depend on the outcome of the DHS trial.

Court appointed lawyers for the children will claim “best interest of the child” while ignoring the extreme abuse of children and infants who are separated from their families with ZERO evidence by Oregon DHS/CPS.

To find a good lawyer is not easy. They need to believe in your case, they need to show you cases they have won against DHS. Get a sense if this is all just a game to them, win one, lose one? How they talk about money is an important indicator. Of course they have to be paid. But different lawyers see money different ways. Few will ever take a case on contingency. You need a good working relationship with your lawyer with some level of trust. Because they represent you don't sit back and expect them to take note of everything. If you have concerns if they are going to speak up about something, ask them in advance before the opportunity is lost. Don't be afraid to coach them right in court with a note.

Ask the attorney about strategy. You will find out how experienced they are and if they are listening to your concerns. Try not to overwhelm them with information despite the fact that this is an extremely overwhelming emotional time for you. Focus.

Keep ahead of your bill. When you don't pay, work will slow down. They may not tell you that, so expect it.

## **The Oregon State Bar is Guilty**

The Oregon State Bar must take responsibility for much of the agony placed on families by judges and DHS as it is an enormous cash cow for lawyers all over the state, an endless stream of cases and cash. Lawyers become judges, No? Judges cooperate with DHS.

The Oregon State Bar is a self appointed agency. They have no legitimate authority except to dominate the courts between judges and defendants. They create the ring. You and the judge and the DA and the court appointed lawyers are in the ring and they all beat the hell out of you till your money and health and family are gone. But no one addresses the system that allows this.

## **The Lawyer Dilemma**

While DHS cases are a massive cash cow in Oregon, there are not enough organized lawyers to take on the DHS cases defensively and offensively with civil action.

Lawyers are approaching the issue piecemeal, when a lawyer pool is needed to address this very corrupt system.

The DHS court and overall judicial system works against targeted families.

Wealthy or well financed families are seldom targeted.

Low income families, minority families, bi-racial families and handicapped families are targeted first. DHS picks on the families least able to fight back.

DHS generates a massive cash cow exploiting the children with little risk to themselves. If DHS uses poverty as a case against your family how is \$50,000 to \$100,000 or more of new debt for legal bills going to help? DHS knows their own hypocrisy. DHS overpowers families.

DHS works to wear down and exhaust parents emotionally and financially in order to gain the upper hand. This is not new information to lawyers, legislators or government workers who claim to listen to the public.

The majority of lawyers in the “lawyer monopoly on justice” fail to oppose the system or at least put up a good battle against DHS. If you find a good lawyer who will take on DHS because they dislike the injustice that they see, you are lucky.

Maybe it takes more than one or two good lawyers to change the system. But after a few go arounds it should be obvious that the family court system is a rigged system that needs to be done away with. Change will require more lawyers to join together and lobby for an end to these abuses.

### **The Legislature Allowed This to Happen**

Ultimately writing laws that control agencies is the responsibility of elected officials. In the case of DHS/CPS the Oregon Legislature is responsible for oversight and review. The question is, where is their power? The abuses by DHS/CPS are well documented in the press. One need not look far. So why has the Legislature not done something that makes a difference? Is it indifference or just gross incompetence? What ever it is, the Legislature is dysfunctional in its oversight of an agency that burns through tax payer money and has a dismal record of abuse, deaths in foster care, and destruction of families. Due to the hallowed halls and nice clothes of the state capitol your case is seen as irrelevant. A matter of class difference, it “doesn’t happen to nice people”.

### **Lack of Accountability**

#### **The Governor’s Advocacy Office (advocates for DHS)**

The Governor’s Advocacy office in Oregon is a DHS defender. They are not there for YOU. The Governor’s advocacy office is made out to be there for citizens but one phone call and the tone immediately tells you they are not there to assist you. The Governor’s Advocacy Office is there to justify what DHS is doing, just one more partner in the crime of stealing your children. They will not talk to you to correct any problem. They don’t see one. Just imagine if they called you back and said, “You were right, we caught them concealing discovery, concealing documentation and going along with false information to justify taking your children.” What a shock that would be.

#### **Contacting your state Rep/Senator**

While it is important to contact your elected representative, half the time these people



seem incompetent.

The responses are the same. Sign an information release and they will get back to you after they have contacted DHS. And DHS tells them whatever they want and that is usually the end of the matter. They are our elected representatives but spend a lot of times wringing their hands and illustrating that they have very little control or voice on how our agencies behave and perform. The agencies themselves decide how they will interpret law in “administrative guidelines” so they basically regulate themselves. In the case of DHS there are no consequences for anything the case workers or managers do which violates parent’s and children’s rights. They tell the legislators that they are just following policy, (so was Eichmann) or that they are just following court orders when in fact it was the DHS lawyer (From DOJ) who told the judge what it was they wanted and the judge gave it to them.

Legislators have no idea what the parents are going through and in my opinion make little effort to try and understand the intensity of the situation. They are not able to put themselves in the shoes of the citizen. They are not willing to. They allow or are powerless to control the agencies that so dramatically effect the lives of the citizens. After they talk to DHS it seems it doesn’t matter what one says. Your voice is no longer important. The Legislators say nothing as if they are just rolling along with what ever DHS puts in front of them. With all the money flowing to DHS and the Legislature supporting them, it is obvious there is no money or intent to help parents or have a true advocate for parents. With all the well known abuses of families by DHS one would think that having a true advocacy office for parents to make sure their voices are heard would be a priority. This shortfall is also a failure of the Legislature. They only want the cash cow to continue.

### **Contacting your Federal Rep/Senator**

The Congress Representative and the US Senator have a more professional staff and actually get you research information that you ask for relevant to your case with DHS. One example of this would be how much Federal money in Title IV-e funds flow into Oregon. Federal funds are an incentive for DHS/CPS to take away your children. If they don’t remove your children from your home they do not get Title IV-e funds. The entire system is set up to destroy families and traffic children. In the US more than 400,000 children are in foster care. In addition the Federal Government pays a bonus for the number of children who are adopted out. This is another incentive to scatter children away from their parents rather than reuniting families. With unlimited power and very little oversight DHS/CPS take the action that increases their funding and grows their agency. Their agency grows the fastest when they take away children.

### **Oregon’s Gov. Kate Brown**

Gov. Brown’s policy to resolve issues with DHS is to throw more money at the agency and hire hundreds of new workers so that more children can be taken from their families

faster. No where will you see increased oversight or staff being held accountable. Exactly the opposite, Gov. Brown set out to make sure that there is a DOJ lawyer for DHS in each county to defend their actions. Once again that means that the DOJ lawyers are not working for justice but to defend the actions of DHS and tell the court what they want. And that is what they get. Once again, taxpayer money paid to destroy families, not to gain justice. Justice in the American court system has become a joke.

### **DHS Notice and Practice of Civil Rights**

Freedom of speech. DHS will decide what it is. If you make any negative comment about DHS to your children they will make a no contact rule against you so that you cannot contact your children without their permission. In other words you do not have freedom of speech to discuss what you would like with your children. Stacey Daeschner, Polk and Yamhill County DHS manager was famous for this.

DHS violates their own policy.

Title IVe funds for Adoption in the state of Oregon was \$66 million. \$11 million for Kinship assistance. The Federal share of that was a whopping \$44 million for Adoption assistance and \$7 million for Kinship assistance. \$8.2 million to child welfare and court systems handling child abuse cases. Notice how much more is spent to adopt children than **AWAY** from kinship.

3. Have “good coms” - Communicate well with others. Stay in touch. Keep your circle of friends informed as to what is happening in your case. Ask for suggestions and weigh them to see if you want to use them in your plan. Share skill and knowledge.
4. Organize - Meet up face to face with other people working on DHS issues.
5. Print literature and stickers and help get the word out there how DHS/CPS operates.
6. Join forces with effective people. (Where are the “Oath Keepers” defending constitutional family rights?)

#### **Push Back Against DHS**

Most families are so stressed out they are afraid to fight back against DHS and their huge funding.
